

## YWCA Kids Place /YWCA Summer Camp Wendy’s Scholarship Agreement

1) I agree that I am the parent/custodial guardian applying for discounted tuition for YWCA Kids Place Before/Afterschool and/or Summer Day Camp programs on behalf of children in my care.

2) I agree that I am **not** eligible for PFCC (Publicly Funded Child Care).

*\*\*To be eligible for PFCC you must make less than 130% of the FPL (federal poverty level) maximum monthly income.*

3) I agree that there is a need for this scholarship for my family due to the fact that I am working full time and/or attending school.

4) I agree that I meet the established income level.

The monthly income standards are as follows:

5) I agree that I will complete the scholarship application and provide paystubs for all employed adults over 18 years of age from the past 30 days.

6) I agree that I will re-submit this information every 90 days to ensure I qualify for this scholarship.

7) I know that scholarships will cover a **portion** of my child’s tuition, and that I am responsible for bi-monthly fees, charged on the 1<sup>st</sup> and 15<sup>th</sup> of each month during the school year, and every Wednesday prior to the upcoming week attending the Summer Day Camp program.

8) I agree that sibling discounts do not apply to scholarships.

9) I agree to be communicative with the YWCA Finance Department and with the YWCA Kids Place program, to respond to inquiries about qualification materials and to ask questions. I also agree that failure to respond to requests for information or falsification of any documents could lead to a loss of scholarship, loss of child care services and/or request for return of scholarship dollars.
